#### ❖ 設置

### ⚠ 乾電池に関するご注意

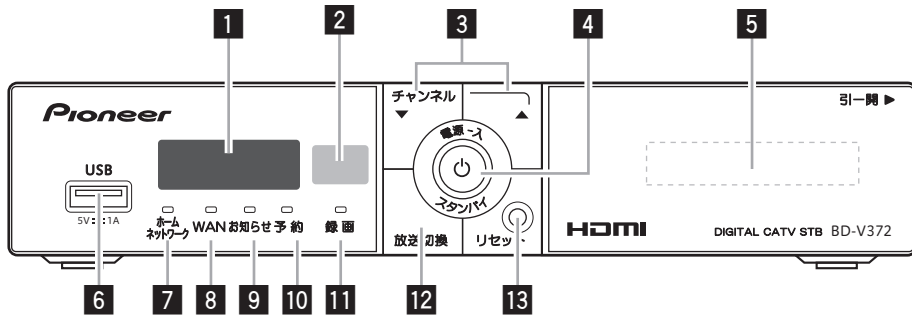
- 新しい電池と古い電池および種類の違う乾電池を混ぜて使わないでください。電池の破裂、液もれにより、火災・けがや周囲を汚損する原因となることがあります。
- 長期間（1 カ月以上）リモコンを使わないときは電池を取り出しておいてください。電池から液がもれて、火災・けが、周囲を汚損する原因となることがあります。
- 電池を機器内に挿入するときは、⊕ と ⊖ の向きに注意し、表示どおり入れてください。間違えると、電池の破裂、液もれにより、火災・けがや周囲を汚損する原因となることがあります。
- もし、液もれが起こったときは、ケース内の液を完全に拭き取ってから、新しい電池を入れてください。万一、もれた液が身体についたときは、水でよく洗い流してください。

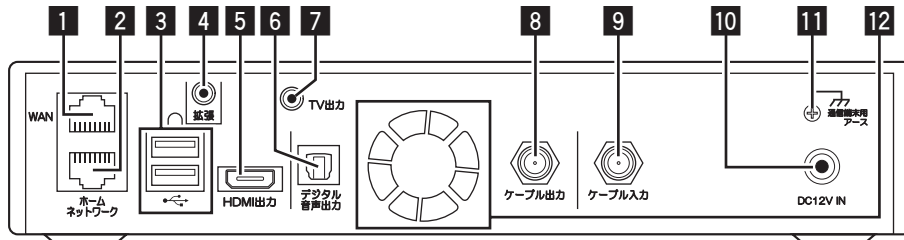

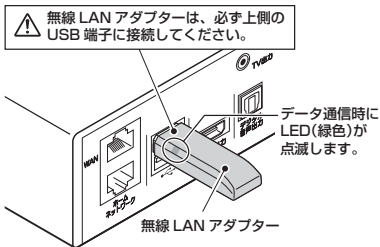

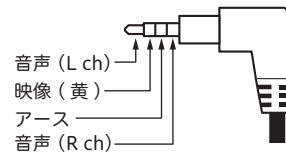

To achieve this, non-free programs must be allowed to use the library. A more frequent case is that a free library does the same job as widely used non-free libraries. In this case, there is little to gain by limiting the free library to free software only, so we use the Lesser General Public License.

In other cases, permission to use a particular library in non-free programs enables a greater number of people to use a large body of free software.

For example, permission to use the GNU C Library in non-free programs enables many more people to use the whole GNU operating system, as well as its variant, the GNU Linux operating system. 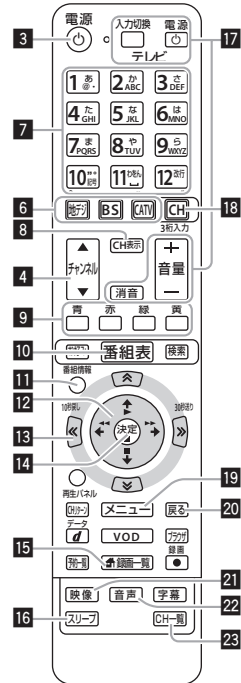
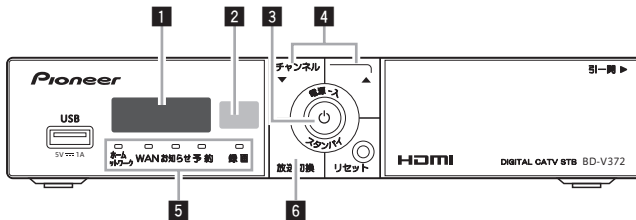
